# ROUNDTABLE WORKSHOP ON CLEANTECH AND INDIA'S VISION

### September 7, 2012 at Paharpur Business Centre, 21, Nehru Place Greens, New Delhi - 110019, INDIA

### **Background**

It is felt that the approach of cleantech development and promotion in India needs a sharp focus to further strengthen its financial modality, support infrastructure, and regulatory approval to promote clean energy as per the stipulated vision statement. For this, the country needs periodic debates and discourses under the aegis of relevant ministry like Ministry of New and Renewable Energy as well as Ministry of Environment and Foresting, which will create an enabling environment to reach at the national development goals and mission with better efficacy and vigor.

The current edition in India aims to provide clear understanding about the most recent issues and concerns of clean energy promotion in India, and to identify a set of key action items in the form of policy paper, which will be useful for the regulatory bodies and policy makers of India. It is also expected that the Energy Vision 2030 of WGSI will be released in India during the event. The event is organized in form of a rountable workshop by the Jagurih Group and its partners in support of the Waterloo Global Science Initiative (WGSI), a partnership between Perimeter Institute for Theoretical Physics and the University of Waterloo.

The objective of this round table workshop is designed to provide clear understanding about the most recent issues and concerns of clean energy promotion in India, and to identify a set of key action items in the form of policy paper, which will be useful for the regulatory bodies and policy makers of India. It is also expected that the workshop will flag key success factors, which are important to consider for realizing the India's visions on clean and renewable energy promotion.



The event is expected to be attended by the public and private policy makers, industries, professionals and investors. The round table workshop will mainly target three ministries and government departments, viz., Ministry of New and Renewable Energy, Ministry of Environment and Forest and Ministry of Energy. The government departments, targeted for the conference is: The Bureau of Energy Efficiency (BEE) and the Indian Renewable Energy Development Agency (IREDA), which is a non-banking financial institution under the administrative control of the Ministry of Energy. It is also planed that the Energy for All Secretariat of Asian Development Bank will also be involved in the conference. Other important audience for the conference will be from the Department of Science and Technology, Govt. of India, The Energy Research Institute, bilateral agencies like NORAD, DANIDA, DFID, SID, Nordic Development Agency, USAID, UNDP, GIZ, The World Bank and Asian Development Bank's local officials, policy makers and industry members of the Confederation of Indian Industries (CII), Indian Institute of technology and other institutes.
